## Conference on Sraffa's Production of Commodities after Twentyfive Years

1985 marks the 25th anniversary of the publication of Piero Sraffa's Production of Commodities by Means of Commodities. During these years the theoretical approach Sraffa sought to revive and develop in this book and in his earlier work, particularly his monumental edition of Ricardo, as well as the criticisms he advanced of contemporary mainstream theory, have given rise to lively debates. For this occasion, Political Economy-Studies in the Surplus Approach is promoting a Conference to be held in Florence (Italy) from the 24th to the 27th of August, 1985.
